



F Street Development Group (FSDG) recently announced the successful closing of the Greenlink Residences development project in Brown Deer, Wisconsin. The development features a collection of market rate apartments that have proven to be popular among renters, as the apartments are over 95% leased as of December 2022.

In March 2023, FSDG closed on permanent debt with Fannie Mae, and returned 100% of accrued preferred return and 20% of invested capital. Now, FSDG is making monthly distributions of free cash flow on an ongoing basis. We anticipate returning the full amount of investors' capital within 4 years, after which investors will retain full equity stake in the project.
